article 13 EU Reg. 679/2016

Dear Customer/Supplier,

We wish to inform you that EU Regulation 679/2016 (and Legislative Decree no. 196/2003 as amended and supplemented, only to the extent that this complies with EU Regulation 679/2016) provides for the protection of natural persons with regard to the processing of personal data (the "Data"). According to such regulation, such processing will be based on principles of correctness, lawfulness and transparency, protecting your privacy and your rights.

Purpose of processing

The Data will be processed for the following purposes:

- A. establishment and management of commercial/professional relationship and related organisational activities;
- B. use of services/purchase of goods, to which the commercial/professional relationship established with the Controller refers;
- C. management of related pre-contractual, contractual, administrative, accounting, tax and legal obligations.

Obligatory or optional nature of data provision | Consequences of any refusal and/or failure to consent to processing | Legal basis of processing

The provision of Data is required to achieve the purposes referred to in paragraph C above (management of related pre-contractual, contractual, administrative, accounting, tax and legal obligations.) and failure to provide such data could result in the breach of specific administrative, accounting and taxation rules of law: the legal basis for processing for the above purposes are precise legal obligations (administrative, accounting and taxation) of the Controller.

The provision of Data for the purposes referred to in letter **A. and B.** above. (establishment and management of the commercial/professional relationship and related organisational activities; use of services/purchase of goods, to which the commercial/professional relationship established with the Controller refers) is optional, but failure to provide the data could make it impossible to establish the contractual relationship; the legal basis for processing for the above purpose is the conclusion and execution of a contract.

Data Recipients

Your data may be communicated to:

- Consultants in the field of administration, accounting and taxation;
- Banks;
- Lawyers and law firms for legal advice;
- Couriers and forwarders;
- Credit Insurance companies limited to Customer Data;
- Public bodies and other institutions for legal obligations.

The communication of the Data described above is, as the case may be, related to specific legal or contractual obligations or strictly related to normal business operations within the management of the contractual relationship established and is strictly necessary for the processing purposes described above.

Your personal data will not be disseminated.

Data storage period

For the purposes referred to in letters **A., B. and C.**, the Data will be stored for 10 years.

The Data Controller also informs you that:

- a) you are entitled to ask the Data Controller to access and rectify or erase your personal data or to limit the processing of your personal data or to object to its processing and you are also entitled to data portability (article 15, article 16, article 17, article 18 and article 20 of the GDPR);
- b) you are entitled to revoke consent at any time without prejudice to the lawfulness of the processing based on the consent given prior to revocation;
- c) you are entitled to lodge a complaint with a supervisory authority.
